AN ORDINANCE OF THE TOWN COMMISSION OF THE TOWN OF HILLSBORO BEACH, FLORIDA, AMENDING THE TOWN'S CODE OF ORDINANCES BY AMENDING CHAPTER 12 ENTITLED LAND DEVELOPMENT CODE, SPECIFICALLY SECTION 12-399 ENTITLED "MAINTENANCE OF LANDSCAPED AREAS" BY CREATING SECTION 12-399 (J) TO BE ENTITLED "ANNUAL REMOVAL OF COCONUTS REQUIRED"; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Commission has determined that it is in the Town's best interest to insure the safety of properties located in the Town from flying debris caused by tropical events; and

WHEREAS, proper tree maintenance during hurricane season is important so as to protect adjacent properties from potential damage; and

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN OF HILLSBORO BEACH, FLORIDA THAT:

Section 1. The foregoing "Whereas" clause is hereby ratified and confirmed as being true and correct and is hereby made a part of this Ordinance.

Section 2. Chapter 12 of the Code of Ordinances is hereby amended by specifically amending Section 12-399 entitled "Maintenance of Landscaped Areas" by creating 12-399(J) to read as follows:

(J) It shall be unlawful to allow a coconut tree between June 1 and November 30 of each year to have coconuts exceeding six (6) inches in diameter.

Section 3. If any section, subsection, sentence, clause or provision of this Ordinance is held invalid, the remainder of this Ordinance shall not be affected by such invalidity.

Section 4. That all ordinances or parts of ordinances and all resolutions or parts of resolutions in conflict with this Ordinance are repealed to the extent of such conflict.

Section 5. It is the intention of the Town Commission of the Town of Hillsboro Beach, that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of Town of Hillsboro Beach, Florida, and the Sections of this ordinance may be renumbered, re-lettered and the word "Ordinance" may be changed to "Section," "Article," or such other word or phrase in order to accomplish such intention.

4 **Section 6.** This Ordinance shall be effective fifteen (15) days after its passage and
