ORDINANCE NO. 2018-08

AN ORDINANCE OF THE TOWN COMMISSION OF THE TOWN OF HILLSBORO BEACH, FLORIDA, AMENDING THE TOWN'S CODE OF ORDINANCES BY AMENDING CHAPTER 6 ENTITLED THE "GARBAGE AND TRASH DISPOSAL", SPECIFICALLY AMENDING SECTION 6-37 ENTITLED "FREQUENCY OF PICKUP" TO PROVIDE FOR SPECIFIC HOURS IN WHICH CONTAINERS CAN BE PLACED ROADSIDE; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Commission has determined that it is in the Town's best interest to address hours for the roadside placement of refuse containers; and

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN OF HILLSBORO BEACH, FLORIDA THAT:

Section 1. The foregoing "Whereas" clause is hereby ratified and confirmed as being true and correct and is hereby made a part of this Ordinance.

Section 2. Chapter 6 of the Code of Ordinances is hereby amended by specifically amending Section 6-37 entitled "Frequency of Pickup" which shall read as follows:

Refuse collection shall be twice weekly at least three (3) days apart. The first collection per day shall not be before 7:30 am. Refuse collection in the Town shall be conducted between the hours of 7:30 a.m. and 6:00 p.m. with no service on Saturday or Sunday. In an emergency situation, or to maintain schedules due to holidays, the collector, with prior approval of the town manager, may deviate from the above schedule. No trash containers, garbage containers, refuse containers and recycling containers shall be placed roadside earlier than 4:00 p.m. of the day preceding the scheduled collection, and all trash containers, garbage containers, refuse containers and recycling containers shall be removed from the roadway no later than 9:00 p.m. on the day of collection.

All items that are to be collected as bulk items shall not be placed at the road more than forty-eight (48) hours in advance of the bulk pick up collection date.

Section 3. If any section, subsection, sentence, clause or provision of this Ordinance is held invalid, the remainder of this Ordinance shall not be affected by such invalidity.

Section 4. That all ordinances or parts of ordinances and all resolutions or parts of resolutions in conflict with this Ordinance are repealed to the extent of such conflict.

Section 5. It is the intention of the Town Commission of the Town of Hillsboro Beach, that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of Town of Hillsboro Beach, Florida, and the Sections of this ordinance may be renumbered, re-lettered and the word

1 "Ordinance" may be changed to "Section," "Article," or such other word or phrase in order to accomplish
2 such intention.

4 **Section 6.** This Ordinance shall be effective fifteen (15) days after its passage and adoption
5 by the Town Commission of the Town of Hillsboro Beach.
